## SUMMARY ANNUAL REPORT FOR TEAMSTERS UNION 25 HEALTH SERVICES & INSURANCE PLAN

This is a summary of the annual report for the Teamsters Union 25 Health Services & Insurance Plan, EIN 04-6374631, Plan No. 501 for the period September 1, 2019 to August 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay directly for weekly accident and sickness, hospital, medical, surgical, dental, vision care, prescription drug, retiree health benefits, hearing care and diagnostic health screening claims incurred under the terms of the Plan.

### INSURANCE INFORMATION

The Plan has contracts with the Symetra Life Insurance Company, Fallon Health and Blue Cross Blue Shield of Massachusetts to pay life insurance, accidental death and dismemberment claims and health claims incurred under the terms of the Plan. The total premiums paid for these contracts were \$106,517,265. Because the Blue Cross Blue Shield of Massachusetts contract is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the fund year ending August 31, 2020, the premiums paid under such "experience-rated" contracts were \$105,466,491 and the total of all claims paid under these "experience-rated" contracts during the year were \$80,999,864.

### BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the Plan was \$237,434,674 as of August 31, 2020, compared to \$207,545,308 as of September 1, 2019. During the plan year, the Plan experienced an increase in its net assets of \$29,889,366. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of the assets acquired during the year. During the plan year, the Plan had total income of \$183,024,889, including employer contributions of \$148,340,014, participant contributions of \$7,025,826, realized losses of (\$188,841) from the sale of assets, earnings from investments of \$23,440,551, and other income of \$4,407,339.

Plan expenses were \$153,135,523. These expenses included \$4,424,015 in administrative expenses and \$148,711,508 in benefits paid on behalf of participants and beneficiaries.

- An accountant's report;
- Financial information and information on payments to service providers;
- Assets held for investment;
- Transactions in excess of 5% of plan assets;
- Insurance information, including sales commissions paid by insurance carriers; and
- Information regarding any common or collective trusts, pooled separate accounts; master trust or 103-12 investments entities in which the plan participates.

If you request a copy of the full annual report from the Plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
